Whereas, the draft rules, namely, the Goa Legal Metrology (Amendment) Rules, 2022 which the Government of Goa proposed to make in exercise of the powers conferred by sub-sections (1) and (2) of section 53 of the Legal Metrology Act, 2009 (Central Act No.1 of 2010) so as to further amend the Goa Legal Metrology Rules, 2011, were pre-published as required by sub-section (4) of section 53 of the said Act in the Official Gazette, vide the Government Notification No. 6/2/2022-CLM/195/452, dated 28-04-2022 published in the Official Gazette, Series I No. 4, dated 28-04-2022, of the Department of Legal Metrology, Government of Goa inviting objections and suggestions from all persons likely to be affected thereby within a period of 45 days from the date of publication of the said Notification in the Official Gazette;

And whereas, the said Official Gazette was made available to the public on 28-04-2022;

And whereas, no objections and or suggestions have been received from the public on the said draft Rules by the Government within the said period.

Now, therefore, in exercise of the powers conferred by section 53 of the Legal Metrology Act, 2009 (Central Act No. 1 of 2010) and all other powers enabling it in this behalf, the Government of Goa hereby makes the following rules so as to further amend the Goa Legal Metrology Rules, 2011, namely:—

1. *Short title and commencement.*— (1) These rules may be called the Goa Legal Metrology (Amendment) Rules, 2022.

(2) They shall come into force from 1st day of September, 2022.

2. *Amendment of Schedule II and III.*— For the existing Schedules II and III appended to the Goa Legal Metrology Rules, 2011, the following Schedules shall be respectively substituted, namely:—

1/1/2019-PER

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and in supersession of the Government Notification No. 1/1/2019-PER dated 27-11-2019, published in the Official Gazette, Series I No. 37, dated 12-12-2019, the Governor of Goa hereby makes the following rules to regulate the recruitment to the Group 'B', Non-Gazetted, Non-Ministerial post, in the Directorate of Higher Education, Government of Goa, namely:—

1. *Short title, application and commencement.*— (1) These rules may be called the Government of Goa, Directorate of Higher Education, Group 'B', Non-Gazetted, Non-Ministerial post, Recruitment Rules, 2022.

(2) They shall apply to the post specified in column (1) of the Schedule to these rules (hereinafter called as the “said Schedule”).

(3) They shall come into force from the date of their publication in the Official Gazette.

2. *Number, classification and level in the pay matrix.*— The number of posts, classification of the said post and level in the pay matrix attached thereto shall be as

specified in columns (2) to (4) of the said Schedule:

Provided that the Government may vary the number of posts specified in column (2) of the said Schedule from time to time subject to exigencies of work.

3. *Method of recruitment, age limit and other qualifications.*— The method of recruitment to the said post, age limit, qualifications and other matters connected therewith shall be as specified in columns (5) to (13) of the said Schedule.

4. *Disqualification.*— No person who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service:

Provided that the Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. *Power to relax.*— Where the Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Goa Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

6. *Saving.*— Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for Scheduled Castes, Scheduled Tribes, Other Backward Classes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Government from time to time in that regard.

These rules are issued in consultation with the Goa Public Service Commission conveyed vide its letter No. COM/II/13/46/(1)/2022/505 dated 23-06-2022.
